Anil Sharma, Joint Controller (Audit), SV&ACB, HQ, Shimla and shall make available all relevant records, registers, vouchers, bank statements and other connected documents as and when called for, to enable completion of the Audit within the stipulated time.

Sh. Anil Sharma, Joint Controller (Audit), SV&ACB, HQ, Shimla, shall submit the Audit Report, along with his findings and recommendations, if any, to the Director General of Police, SV&ACB, H.P, within 15 days from the date of issue of this order.
