12. First Information contents (प्रथम सूचना तथ्य):

A complaint has been submitted by SI Jasbir Chand, SV and ACB, Una. The contents of the complaint are as under:- On 21-09-2012 Varun Kumar s/o Mohan Lal resident of VPO Gagret, Una, HP applied to Subject Matter Specialist, Agriculture, Gagret (hereinafter called SMS) for availing Government project-assistance (subsidy), for construction of polyhouse under the GoHP Scheme Pt. Deen Dayal Kisan Bagwaan Smridhi Yojna. Under this Scheme subsidy of 80% was being provided to the applicant farmers for construction of polyhouses. Deputy Directors of Department of Agriculture, GoHP in each district were made District Nodal Officer (hereinafter called DNO) for approval of polyhouse project and subsequent sanction payment of subsidy under the Scheme. SMS in each agriculture block of the district was made Project Implementing Agency (hereinafter called PIA). SMS is senior most officer of the agriculture department in each block. He, as PIA, was to process the proposal of an applicant farmer for project-assistance (subsidy) for construction of polyhouse after verification of feasibility etc., and then to submit the project proposal to DNO for administrative approval. After the approval of proposal by DNO, the SMS assisted by his team comprising of ADO(Agriculture Development Officer), JE or AEO (Agriculture Extension Officer), would get the polyhouse constructed by exercising 100% test check during different phases of execution of the project components. He would prepare submit claims of project assistance along with photographs of the polyhouse along with the beneficiary farmer and the banker (if loan taken from the Bank) to the DNO. On the report of SMS, the DNO would pay subsidy amount to the farmer or to the Bank, if loan was availed under the Scheme by the farmer. The site of polyhouse proposed by Varun Kumar was Khewat No.4, Khatauni No.4, Khasra No. 1038, kitta 1 as entered in the nakal jamabandi for the year 2008-2009 situated in mahal Krishna Nagar, mouja Gagret, then tehsil Amb, district Una, HP. Revenue document of this land was also submitted by Varun Kumar along with his application to SMS on 21-09-2012. This land is entered in the revenue record as gair mumkin khad. This land is situated on riverbed of a seasonal khad(rivulet), a tributary of Swan river of Una. In spite of non-feasibility of construction of polyhouse on riverbed, Mr. Yadhuvir Singh, the then SMS Gagret, forwarded the proposal to DNO who approved the project for obtaining subsidy vide his office letter no. Agr. Una (f) 6-5/2012-5759 dtd. 10-10-2012 for construction of polyhouse and micro irrigation system in it with an estimated cost of Rs 7,92,728/- Rs. 80,000/- respectively, totaling Rs. 8,72,728/-. Copy of this approval letter was also endorsed to the Manager KCCB Ltd, Branch Gagret, District Una. On 25-11-2012, Varun Kumar submitted an application to KCCB Ltd Branch, Gagret for obtaining loan of rupees eight lakh for this proposed polyhouse. On his application loan of Rs. 7,99,500/ was sanctioned by manager Inderjeet Sharma on 27.11.2012 which was disbursed into Varun Kumars loan account in parts on 27.11.2012 8.12.2012 and further transferred from his loan account to the account of M/s Kuldeep Chand Polyhouse Works, who had been cited as a polyhouse builder. Kuldeep Chand s/o Des Raj, VPO Kuthera Jaswalan, Tehsil Gagret, District Una, is the proprietor of this firm. Polyhouse was not built but Mr. Yudhvir Singh Guleria, the then

SMS Gagret, submitted false completion report on 31.12.2012 in r/o the polyhouse of Varun Kumar, the report is also signed by two other officials. On the report of SMS, subsidy amount of Rs. 6,98,182/- for this polyhouse was sanctioned by DNO on 17.1.2013 and cheque of Rs. 6,98,182/ was issued which was deposited into loan a/c no. 50053414281 of Varun Kumar and this loan account was closed. The site of the polyhouse shown on record i.e. above said khasra no. 1038, was visited during the course of enquiry along with SMS Gagret and revenue officials on 3.10.2020. The site was inspected but no polyhouse or its remnants were found on this land. A site inspection report was prepared by the SMS. In this report it has been mentioned that polyhouse construction is not feasible on this land. Hence Varun Kumar and Kuldeep Chand hatched a conspiracy in connivance with the officers of Department of Agriculture and KCCB Ltd. Branch, Gagret and fraudulently made withdrawal of Government subsidy amounting to Rs. 6,98,182/ostensibly for construction of polyhouse which was never constructed. Thereafter, Varun Kumar in complicity with his brother Arun Sharma hatched another conspiracy to defraud the public exchequer by claiming subsidy for construction of polyhouse on the same piece of land on riverbed bearing Khewat No.4, Khatauni No. 4, Khasra No. 1038, kitta 1 as entered in nakal jamabandi for the year 2008-09 situated in mahal Krishna Nagar mouja Gagret. Proposal for construction of polyhouse was applied in the name of Arun Sharma s/o Mohan Lal, VPO Gagret, District Una. On 10.7.2012, the application of Arun Sharma was received by Yudhvir Singh, the then SMS Gagret who submitted its report to the DNO for administrative approval for grant of subsidy in the proposed polyhouse project of Arun Sharma. In this report he has recorded to have visited the site of proposed polyhouse on 9.8.2012 and estimated cost of project was shown as Rs. 8,72,728/ and project share (eligible subsidy) as 6,98,182/. Proposal was approved for subsidy by the DNO Una. This polyhouse was also not built, but Yudhvir Singh, the then SMS Gagret, submitted false completion report with bills to the DNO for drawal of project assistance (subsidy) of Rs. 6,34,182/ for polyhouse plus Rs. 64,000/ for micro irrigation system in it, total amounting to Rs. 6,98,182/. This amount was sanctioned by the DNO and cheque of Rs. 6,98,182/ was issued to the KCCB Ltd. Branch Gagret which was credited into account of Arun Sharma. Thus Arun Sharma and Varun Kumar in connivance with the officers of Department of Agriculture fraudulently made withdrawal of Government subsidy amounting to Rs. 6,98,182 /- ostensibly for construction of polyhouse which was never constructed. Thus Varun Kumar, Arun Sharma, Kuldeep Chand in connivance with officers of agriculture department namely Mr. Yadhuvir Singh, the then SMS of Gagret block and officials of KCCB Ltd. Gagret, fraudulently withdrawn subsidy amount of Rs. 13,96,364/- from the deptt. of agriculture GoHP by preparing and submitting false records. Hence offences of criminal conspiracy, criminal breach of trust, cheating and false verification of utilization of subsidy are made out against them. Therefore registration of case FIR u/s 120B IPC read with 406,409,420,467,468,471 IPC and Section 29 of HPPSCP Act 1983, is recommended to be registered against the offenders please. The enquiry into the matter was conducted by the undersigned and report was submitted to the higher authorities vide this office letter no. 1864 dtd.08.10.2020. The approval for registration of FIR was received from the competent authority vide letter no. SVACB(R-NR/VHQ)-Comp(Una) 9133/ 2020-17724 dated 21.10.2020. Action at Police Station:- On the contents of complaint offence under section 120B IPC read with 406,409,420,467,468,471 IPC and Section 29 of HPPSCP Act 1983, are made out against the offenders. Hence FIR is hereby being registered. Copies of FIR are being printed and sent to the Ld. Court of Special Judge Una and higher authorities. Case being special-reported, therefore copy of FIR may be treated as special report.
