That an enquiry into the complaint No 04/2020 dated 19-02-2020 regarding allegations of irregularities in the construction work of Nature Park at Kanlog, Shimla (Darni Ka Bagicha) was conducted by SI Inder Lal, E/O PS SV & ACB Shimla and enquiry report was submitted to VHQ for registration of a criminal case. The necessary approval has been received from the competent authority and conveyed vide VHQ letter no SV&ACB (R-SR/VHQ)-Comp(SML)04/2020-13477 Dated 29-6-2022 and SP,SV&ACB SR office letter endst. No 4838 Dated 29-6-2022 along with enquiry file and annexed record. A separate complaint has been submitted by enquiry officer which is reproduced It is submitted that an enquiry into the complaint No. SV&ACB (R-SR- HQ) Comp. (SML) 04/2020 dated 19-02-2020 regarding allegations of irregularities in the construction work of Nature Park at Kanlog, Shimla (Darni Ka Bagicha) that, i) The construction material for civil works have been procured locally on piece meal bases and the work has been executed on labour rate by splitting up the work in numerous parts without going for press/e-tendering which is a violation of HPFR-2009 for contracting or outsourcing of services or works. ii) There appears to be lack of technical inputs during construction of civil works as there are neither aesthetic nor structurally strong and have started cracking/wearing out. The composite masonry executed is below specification. iii) A sum of Rs. 12,78,448/- has been spent on watering of the plants and the lawn (Korean Grass), whereas water is

available in the park through alkatheine pipes connected to the local perennial sources. The watering of plants/grass through contractors instead of departmental labour has resulted in wastage of the funds. iv) Plants amounting to Rs. 4,46,050/- and Korean Grass amounting to Rs. 1,62,500/- have been purchased on piece meal basis in violation of ACS (Forest) to the GoHP instructions issued vide number FFE-A (B) 2-16/2015 dated 12.06.2017. The complaint was received in this office with the direction to take necessary action into the matter and same has been entrusted to me for further enquiry. During the course of enquiry, it revealed that the construction work of Nature Park started in the May 2017 up to March 2019, in the supervision of DFO (U) Shimla. As per the DPR, total amount of Rs. 4,36,38,800/- has been estimated for the construction of Nature Park Kanlog under CAMPA. The administrative approval and expenditure sanction has been accorded for the development of Nature Park at Kanlog for Rs 436.30 lakhs by the Chairperson, Steering Committee of HP State CAMPA dated 30.08.2017. Further, provision of Rs 80 lakhs was made for the development of Nature Park, Kanlog by the Steering Committee of State CAMPA against which a sum of Rs. 72,28,867/- incurred up to 31.03.2018. subsequently, sum of Rs. 60 lakhs was allotted during year, 2018-19 for the said project dated 25.10.2018, out of which Rs. 19,35,202/- was spent and as the information of DFO Shimla (U) vide their office letter dated 25.03.2022, balance amount was surrendered. So, a total expenditure up to 31.03.2019 comes to Rs. 91,64,069/- (72,28,867 + The works, which constructed in Nature Park were of Rs. 89,61,797/development of park area (part-A) and Rs. 45,525/- for landscaping in park area (part-B) with total cost of Rs. 89,87,322/-, whereas, rest of the amount has been shown spent against the fencing work of Jakhu beat. Enquiry further revealed that an expenditure amount of Rs. 91,64,069/-has been spent for the work of Retaining wall Road side, internal water supply and sanitation, electric poles with lights, Mali Hut-cum-store, Development of lawn with flowers & grass, Development of nursery, preparation of estimate & drawing, Fencing of Park Area, Landscaping in park area and the above works have been shown executed by the Forest Department in Nature Park Kanlog. As per the estimate of DPR, 270 mtr long and 2 mtr in height retaining wall to be constructed of stones was proposed for an estimated cost of Rs. 56.65.738/-, whereas retaining wall of length 180.85 mtrs along the road side and 51 mtr PCC wall with total length of 231.85 mtr found constructed on the spot. The said construction work of retaining/PCC wall was executed through the scheduled rates of the Forest Department from the different contractors. An amount of Rs. 19,48,238/- has been paid to different contractors against the labour wages and rest amount of Rs. 22,49,857/- has been spent against the purchase of material i.e cement, sand, gravel, aggregate etc. Total Rs. 41,98,095/- found expenditure against the said retaining/PCC wall. Further, the construction in respect of plinth level has been shown executed on the scheduled labour rates through 14 different contractors, whereas, the work above the plinth level i.e arch has been shown executed by calling E- tender. However the other civil works were executed through the contractors and their labour on the schedule rate of contract of the department and the purchase of sand, concrete and bricks etc. on the different quotations bifurcated in pieces. in order to check the quality of the concrete material of PCC wall constructed in the road side, six different samples were lifted through Geo Tech Engineers and Consultants, from different portions of the PCC wall. The samples were further sent to SFSL Junga for analysis and examination and further sent to E-In-C, Quality Control & Design, HPPWD, Shimla for opinion. As per the report of Quality Control & Design, HPPWD and test reports of Geo Tech Engineers and Consultants, the samples of one portion of the PCC wall found of average compressive strength as 5.6 N/mm square, which is less than that of the required strength of 7.5 N/mm Square, so failed as it does not satisfy the compressive strength criteria. So, false and fictitious entries have been made by the suspect forest officers/officials. An amount of Rs 27.144/- has been shown spent in respect of the Providing internal water supply and sanitation against an estimated amount of Rs. 3,00,000/- as per DPR, an amount of Rs. 1,50,618/- has been shown spent in respect of the providing electric pole with lights against an estimated amount of Rs. 3.50,000/-, an amount of Rs. 4,83,494/- has been shown spent in construction of Mali Hut cum store, against an estimated

amount of Rs. 8,00,000/-, an amount of Rs. 23,31,097/- has been shown spent in respect of the development of lawn with flowers & grass, against an estimated amount of Rs. 25,00,000/-, an amount of Rs. 12,14,028/- has been shown spent in respect of development of nursery, against an estimated amount of Rs. 25,00,000/-, an amount of Rs. 2,88,062/- has been shown spent in respect of preparation of estimate and drawing, against an estimated amount of Rs. 8,00,000/-, an amount of Rs. 2,01,281/- has been shown spent in respect of the fencing of the park area, against an estimated amount of Rs. 15,00,000/-, an amount of Rs. 2,70,250/- has been shown spent in respect of the landscaping in park area, against an estimated amount of Rs. 1,48,28,655/- as per DPR. Further, the expenditure shown against the said works can be verified during the course of investigation. As per the DFO (U) Shimla, office letter No 398 dated 20.05.2022 with regard to deployment of technical officers of the Engineering wing of the Forest Department for monitoring of civil works of said Nature Park at Kanlog, a committee of five officers of the Forest Department was constituted. As per the inspection report, it has been mentioned at Sr. No 9 to 13 about the poor quality of the retaining wall of said Park, at Sr. No 19 about the species-wise detail of plants raised in poly house and quality of potting mixture and also certain observations have been found raised by said committee. Enquiry has established that the shortcomings as observed by the inspection committee of Quality Control Cell of CM office and the facts disclosed during the course of enquiry, false and fictitious entries in MBs have been made against the substandard works. The samples of PCC examined by SFSL and the same were found to be substandard and in conformity with the report of Quality Wing of HPPWD. The said works have been executed through various contractors by Sh Mohan Dass, the then forest Guard Phagli beat, entries made in MBs by Sh. Anand Kishore, the then BO, verified by Sh Ranvir Singh, the then Forest Ranger, Range Chaura Maidan, and Sh Bahadur Singh, the then Dy. Ranger, Addl. charge of RFO Chaura Maidan by splitting into various parts, and finally, Govt. funds wrongfully disbursed by Sh. Inder Kumar, the then DFO Shimla (U) against the construction of Nature Park, Kanlog in connivance with each other. Further, the said officers/officials have also verified the bills with regard to construction of various works and sanctioned/disbursed the funds. The said officers/officials were responsible for the proper execution and supervision of the works. The act of these officers/officials also attract their lack of supervision in the construction works and further wrongful disbursement of Govt. funds, causing thereby wrongful loss to the state exchequer. Prima facie, the allegations attract commission of offences punishable u/s 420, 468, 471, 120-B IPC and Section 5, 6 and 13 of HP Specific Corrupt Practices Act, 1983 against the forest officers/officials and others. So, it is recommended to register a criminal case for the offences punishable u/s 420, 468, 471, 120-B IPC and Section 5, 6 and 13 of HP Specific Corrupt Practices Act, 1983 against Sh. Inder Kumar, the then DFO Shimla (U) (now retired), Sh Ranvir Singh, the then Forest Ranger, Range Chaura Maidan, (now retired), Sh Bahadur Singh, the then Dy. Ranger, Addl. charge of RFO Chaura Maidan, (now retired), Sh. Anand Kishore, the then BO, (now retired) and Sh. Mohan Dass, Forest Guard, forest beat, Phagli and others. Sd SI Inder Lal E/O PS,SV&ACB Shimla. Action taken:- From the contents of the complaint, a case for the offence punishable u/s 420, 468, 471, 120-B IPC and Section 5, 6 and 13 of HP Specific Corrupt Practices Act, 1983 is made out against Sh. Inder Kumar, the then DFO Shimla (U) (now retired), Sh Ranvir Singh, the then Forest Ranger, Range Chaura Maidan, (now retired), Sh Bahadur Singh, the then Dy. Ranger, Addl. charge of RFO Chaura Maidan, (now retired), Sh. Anand Kishore, the then BO, (now retired) and Sh. Mohan Dass, Forest Guard, forest beat, Phagli and others. A criminal case is registered in this police station and the investigation of the case is entrusted to Inspector Balwant Singh, I/O, PS,SV&ACB,Shimla. Copy of FIR is being sent to the Ld. Court of Chief Judicial Magistrate Shimla and also to the senior officers of SV&ACB, Shimla.
