An enquiry initiated vide VHQ letter No. SV&ACB (R-NR-Hqrs) Comp. (UNA) 5/2020-2028 dated 30.01.2020 on the complaint of Sh. Ajay Sharma s/o Sh. Amarjeet r/o Vill. Katohad Khurd. Tehsil Amb, District Una was received in PS SV&ACB Una vide SP SV&ACB NR Dharamshala Endst. No. 846 dated 10.02.2020. It was alleged that employees of RLA office Amb defrauded the government of revenue in connivance with the higher officials and other persons. At the time of registration of vehicle, they attach fake NOC of Goods Tax causing revenue loss to the state. Also fake slips of Rogi Kalyan Samiti of Government Hospital are attached with the medical certificate of license. The complaint has been enquired into by SI Jasbir Chand of PS SV&ACB Una. During the course of enquiry, it is found that Passenger and Goods Tax (PGT) certificate, which is required at the time of registration of old commercial vehicles, pertains to Excise Department and payment of this tax is not deposited in the RLA office. The vehicle owner is responsible for all the documents ie goods tax clearance & NOC attached with the vehicle registration file. As per the information received from Excise Circle Office Amb, PGT certificates attached with the 04 vehicles i.e HP19A-8900, HP19B-0786, HP19-5376, HP19C-0401 are found fake. Allegations pertaining to fake slips of Rogi Kalyan Samiti of Govt. Hospital are not found substantiated. During enquiry it is found that Sh. Maninder Singh s/o Sh. Gyan Chand VPO Chalet Teh. Amb, Distt. Una, Owner of commercial vehicle No. HP19A-8900, Sh. Riyaz Mohd. s/o Sh. Hussn Mohd. VPO Aloh, Teh. Amb, Distt. Una, Owner of commercial vehicle No. HP19B-0786, Sh. Gurshal Singh s/o Sh. Jeet Singh VPO Badoh, Teh. Amb, Distt. Una, Owner of commercial vehicle No. HP19-5376 and Sh. Rajinder Singh s/o Sh. Roshan Lal, Vill. Kaloh, Teh. Amb, Distt. Una, Owner of commercial vehicle No. HP19C-0401 have caused revenue loss of Rs. 1,19,715/- to the State Government by way of forged certificates. Hence, a criminal case under section 420, 467, 468, 471 IPC against the above vehicle owners has been recommended please. Action At Police Station :- On the contents of enquiry report offence u/s 420, 467, 468, 471 IPC are made out against Sh. Maninder Singh s/o Sh. Gyan Chand VPO
