It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420, 120-B, 201 IPC & section 7,7A, 8, 12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus enquiry No. SIT-5/2023 was ordered into the conduct of Drawing Master Post Code-980 by HPSSC Hamirpur and the same was entrusted to Inspector Mohinder Kumar of Police Station SV & ACB Dharamshala District Kangra. After conclusion of enguiry proceedings, it has been revealed on the basis of enquiry report and enclosed record that Smt. Uma Azad w/o Sh. Naresh Kumar r/o Village Badai P.O. Karot Tehsil Sujanpur District Hamirpur is posted as Senior Assistant in the examination branch of HPSSC Hamirpur who lives with her son named Nikhil Azad at House No.-306 Ward No.-07 Housing Board Colony Hamirpur. It has also been revealed that one lady namely Smt. Sunita Devi d/o Sh. Hans Raj resident of Village & Post-Office Nalti Tehsil Ghumarwin District Bilaspur(H.P.) was a candidate in the recruitment exam of Drawing Master, Post Code-980 under Roll No. 980001710. Screening test for the said exam was conducted on various exam centers on 08.10.2022. Analysis of call detail records revealed that Smt Uma Azad, Smt. Sunita Devi and Nikhil Azad were in touch with each other before the conduct of screening test of said examination.

Smt. Sunita Devi withdrawn an amount of Rs. 50,000/- from her SBI Account Main Branch Hamirpur on 03.10.2022 and also transferred Rs. 50,000/- online to Nikhil Azad on 05.10.2022. It has been further transpired that pecuniary undue advantage of above said description was paid by Smt. Sunita Devi to Smt. Uma Azad & Nikhil before the conduct of screening test on the said date. Smt. Uma Azad in lieu of receiving/obtaining undue advantage of above description, made the question paper of above examination available for reading to Smt. Sunita Devi before the conduct of exam, as a result of which Smt. Sunita Devi was able to secure 28th position in over all final merit list of 400 candidates in General Unreserved Category. Final result of the said examination is yet to be declared. As per the facts revealed on the basis of enquiry report and relevant record, commission of offences punishable under section 420, 120-B IPC & section 7, 7A, 8, 12 Prevention of Corruption Act 1988(as amended in year 2018) have been prima facie disclosed on the part of Smt. Uma Azad, her son Nikhil Azad and Smt. Sunita Devi, above. Hence, a criminal case under section 420, 120-B IPC & section 7, 7A, 8, 12 of PC Act is registered against Smt. Uma Azad, Nikhil Azad and Smt. Sunita Devi above. Copy of FIR is being sent to the competent court and senior officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
