It is submitted that consequent to the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420, 120-B, 201 IPC & section 7,7A, 8, 12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant Information Technology Post Code 965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicious have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Enquiry No. SIT-14/2023 was ordered into the conduct of Junior Office Assistant (Information Technology) Post Code-939 by HPSSC Hamirpur and the same was entrusted to Inspector Hans Raj of Police Station SV&ACB Solan District Solan. After conclusion of enquiry proceedings, Enquiry Officer has submitted his enquiry report dated 27.02.2023. It has been revealed on the basis of enquiry report and enclosed record that objective type screening test for total 295 posts advertised vide advertisement no. 37-3/2021 dated 01.12.21 and 38-1/2022 dated 12.01.22 was conducted through HPSSC Hamirpur. Objective type screening test for the said posts were conducted on 24.04.2022. There were 200 questions in the paper and each question carried half mark. The test was of 100 marks, but later it was converted into 85 marks as per government instructions. Result of the screening test was declared on 20.07.2022 and total 2989 candidates out of 67,434 appeared were declared successful. The typing skill test of qualifying nature was conducted by HPSSC

w.e.f 22.08.2022 to 09.09.2022 and after typing test 909 candidates were called for 15 marks documents evaluation, which was conducted w.e.f 02.12.2022 to 15.12.2022. Final result of the exam is yet to be declared. During the course of enquiry OMR sheets of two candidates namely Vishal Chaudhary S/O Madan Lal R/O Village Bagh PO Majheen Tehsil Khundian Distt. Kangra HP age 24 years, roll no. 939015188 and Dinesh Kumar S/O Sh. Dharam Chand/O Village Bagh PO Majheen Tehsil Khundian Distt. Kangra HP age 24 years, roll no. 939031865 were obtained from HPSSC Hamirpur and same were sent for analysis to SFSL Junga. As per SFSL report, it is proved that these two candidates have filled the circles showing Roll No., Date of Birth, Series of Paper and some of the circles as answers by themselves, while rest of the answers(circles) were filled by some other person (other than these two suspected candidates). Centers of examination of both the candidates were different. Despite that tint of Ink, pattern of execution and pen pressure to fill circles and answers in both the OMR sheets tallied with each other. As per CDR analysis and interview of suspects it was revealed that Kishori Lal (Peon, Secrecy Branch HPSSC Hamirpur) S/O Sh. Jiwnoo Ram R/O Village Jaswani PO Dadhol Tehsil Ghumarwin Distt. Bilaspur HP was in contact with Madan Lal(Peon in HPSSC Hamirpur) S/O Sh. Hari Chand R/O Village Bagh Tehsil Khundian Distt. Kangra HP, who is father of Vishal Chaudhary and also neighbor of Dinesh Kumar. Madan Lal in connivance with Kishori Lal above directed both Vishal Chaudhary and Dinesh Kumar in advance (before appearing in the examination) to solve only those questions for which they were sure about correct answers and leave rest of questions unsolved or unfilled in OMR sheets. Thereafter, Kishori Lal in connivance with Madan Lal, filled the blank circles in both OMR sheets with the help of final answer key (which was available in public domain) before scanning of OMR sheets during the process of scanning of OMR sheets of this post code. Further, other candidates namely Mamta @ Soniya D/O Usha Devi R/O House No. 161, Uppal House, MC Colony Hamirpur age 37 years, roll no. 939018548 is a relative of Uma Rani @ Uma Azad (prime accused in Case FIR No. 04/2022) has passed the screening test of JOA(IT)939 with the score of 79/100. Similarly, Shailja W/O Sohan Singh R/O VPO Dundla Tehsil Bangana Distt. Una, HP age 30 years, roll no. 939016062 has passed the screening test of JOA(IT) 939 with a score of 73.5/100, Sohan Singh being suspect/accused in Case FIR No. 05/22. Also Sh. Gopal Pathania S/O Late Sh. Nikka Ram R/O Village Kalwal PO Laharti Teshil Dhatwal Distt. Hamirpur age 38 years, roll no. 939016013 has scored 85.5/100 (only attempted 88.5 marks paper). It is pertinent to mention here that Sh Gopal Pathania above is the real brother of suspected tout Neetu (who is in close contact with accused Uma Rani @ Uma Azad of Case FIR No. 04/22). The academic qualifications of these three candidates are not in concurrence with scores obtained by them in objective screening test of JOA(IT) 939. Also data pertaining to their typing skill test reveals that their typing test was conducted on 24.08.2022, but their test submission time is delayed as compare to other candidates of the same group, which creates suspicion on their qualifying the typing test as well. As per the facts revealed on the basis of enquiry report and relevant record, commission of offences punishable under section 420, 465, 468, 471 & 120-B IPC have been prima facie disclosed on the part of Sh. Kishori Lal (Peon in HPSSC Secrecy Branch) Madan Lal (Peon in HPSSC) Vishal Chaudhary and Dinesh Kumar above. Whereas, detailed investigation into the role of suspects Mamta @ Soniya, Shailja and Gopal Pathania is required. Hence, a criminal case under section 420, 465, 468, 471 & 120-B IPC is registered against Sh. Kishori Lal (Peon in HPSSC Secrecy Branch), Madan Lal (Peon in HPSSC) Vishal Chaudhary and Dinesh Kumar above. Copy of FIR is being sent to the competent court and senior officers for information and further necessary action. Relevant entries of FIR are being made in the concerned

registers.
