It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420, 120-B, 201 IPC & section 7,7A, 8, 12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspensions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus enquiry No. SIT -8/2023(PC- 819)- Traffic Inspector -7440 Dated 20-03-2023 was ordered into the conduct of (Traffic Inspector) Post Code-819 by HPSSC Hamirpur and the same was entrusted to Inspector Daleep Singh EO, Police Station SV & ACB Dharamshala District Kangra. During enquiry it has been found that HPSSC, Hamirpur vide Advertisement No. 36-3/2020 dated 21-9-2020 had advertised recruitment for 06 posts of Traffic Inspectors (Post code 819) on contract basis on the requisition of the Commissioner Transport, HP

Shimla-4. In response to this total 39,938 applications were received and 35,053 applications were admitted. The Written Objective Type Screening Test was held on 22-08-2021 in which 14,640 candidates appeared and 20,413 candidates remained absent. Out of 14,640 candidates, total 22 candidates were called for further document evaluation process on Government notified parameters. Subsequently result was declared on dated 28-01-2022 and 06 candidates were selected for the post of Traffic Inspector. All six selected candidates have joined their jobs at their respected places. Candidates Ravi and Abhishek Daryal got their posting in Flying Squad Dharamshala, Balwant Singh at Shimla , Hemant Sharma, Anurag Sharma and Kamlesh at Kullu. On the basis of call detail analysis names of two suspect candidates i.e. Ravi Kumar S/O Hardev Singh village Ghanal Khurd Ward No. 5, Hamirpur Distt Hamirpur (Mobile No. 94183-39815) and Abhishek Daryal S/O Amar Singh village Mansimbal PO Bhawarna Tehsil Palampur Distt. Kangra (Mobile No. 94180-30995) were provided by the Tech Cell, VHQ. Selected six candidates were associated in the enquiry. Their Bio-data, family back ground, mobile Nos. academic record, bank account details etc. were procured and analysed. During analysis it is found that candidate Ravi Kumar had transferred Rs.10,000/- on 29-08-2021 through IMPS in Account No. 11500110016596 UCO Bank Hamirpur. This account No. is in the name of Smt. Uma Azad who is accused in case FIR No 4/22 PS SV& ACB Hamirpur. This transaction has been made during the recruitment process of post code 819. From CDR analysis it is clear that selected candidate, Ravi Kumar remained in contact through his mobile number 94183-39815 with accused persons on their respective Mobile Numbers i.e. Uma Azad (94590-01955 & 82787-34594) and her sons Nikhil Azad (82192-69004) & Nitin Azad (82191-63181) w.e.f. 02/01/2021 to 23/12/2022 . He also remained in contact with Kehar Singh (94180-15497) personal secretary to the Chairman of HPSSC Hamirpur (Sh. Satish Kumar Brigadier) w.e.f. 09/02/2021 to 05/02/2022 (Page no 207-247). Candidate, Ravi Kumar did not produce his mobile phone found used during above mentioned conversation and as per his version, he has destroyed it. Forensic examination of the OMR sheet of Ravi Kumar (OMR sheet No. 819005539 & roll number 819005539) confirmed physical erasure marks in respect of seven answers, whereas, in case of candidate, Abishek Daryal his OMR sheet (roll number 819010844) revealed nothing suspicious. As per the conditions mentioned in the question booklet, candidate should not have got the advantage of these altered answers but he has been illegally favoured in this matter also. During investigation of case FIR No 4/22 PS SVACB main accused Uma Azad disclosed that she had provided paper of Traffic Inspector Post code 819 to Ravi Kumar some days before screening test and he was selected for that post and joined as Traffic Inspector at Dharamshala. On the scrutiny of the final result for the post of Traffic Inspector, it has been found that out of the total 6 posts only one post was available under SC (UR) category in which Ravi Kumar has been finally selected. It is also suspected that in order to grab this single post under this category, manipulations other than the leak of Question Paper could also have taken place at other levels as well. In view of the above, it transpires that suspect Ravi Kumar had read the question paper for the post of Traffic Inspector (Post code 819) and in lieu of the same had given undue advantage of Rs.10,000/- to Uma Azad through bank transaction on 29.08.21 i.e, 7 days after the date of written examination of this post code which was held on 22.08.2021 and managed to secure 2nd position amongst S/C candidates in the overall final merit list out of 14640 candidates/aspirants. As such, this position obtained by Ravi Kumar is suspicious as he has done his +2, B.Sc.(IT) and MCA through distance education, the degrees of which are also required to be investigated. Although, Ravi Kumar had been in continuous contact with Uma Azad since a long time but he made calls to her on 21.08.2022 before and on 22.08.2022 after the written examination

and on 29.08.21 as well, the date on which transaction of Rs 10,000/- was made, which makes his conduct suspicious indicating towards having been involved in conspiracy with Uma Azad in compromising the Secrecy of the Question Paper of this post code. Apart from this, there is a possibility of transaction in the form of cash between Ravi and Smt. Uma Azad. Hence, Enquiry Officer has recommended to register a regular criminal case under relevant sections of law against Ravi Kumar, Uma Azad, Nitin and Nikhil for these acts of omission and commission. The roles/involvement of any other official/Staff of HPSSC, Hamirpur, needs to be looked into during detailed investigation of this case. Thus, as per the facts revealed on the basis of enquiry report and relevant record, commission of offences punishable under section 420, 120-B, 201 IPC & section 7, 7A, 8, 12 Prevention of Corruption Act 1988(as amended in year 2018) have been prima facie disclosed on the part of Smt. Uma Azad, her son Nikhil, Nitin Azad and candidate Ravi Kumar, above. Hence, a criminal case under section 420, 120-B, 201 IPC & section 7, 7A, 8, 12 of PC Act is registered against Smt. Uma Azad, Nikhil, Nitin Azad and candidate Ravi Kumar S/O Sh. Hardev Singh Village Ghanal Khurd Ward No 5, Hamirpur Distt. Hamirpur above. Copy of FIR is being sent to the competent court and senior officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
