It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus on 20-03-2023 enguiry was ordered into the conduct of (Auction Recorder) Post Code-899 by HPSSC Hamirpur and the same was entrusted to Inspector Sanjay Kumar IO, Police Station SV&ACB Mandi District Mandi. During the course of enguiry, the relevant record pertaining to Post Code 899 (Auction Recorder) has been procured from HPSSC Hamirpur and the same has been scrutinized. On the perusal of record it is found that HPSSC, Hamirpur vide advertisement No. 37-1/2021 dated 08.04.2021 had advertised recruitment for 06 posts of Post Code 899 i.e. Auction Recorder on contract basis on the requisition of the Managing Director, HP State Agriculture Marketing Board, Shimla-02 to fill up these posts. In response to this advertisement, 1297 applications were received out of which 730 applications were provisionally admitted for written objective type screening test. The written objective type screening test was held on 11.09.2021 in which 405 candidates appeared and 325 candidates remained absent. Based on the merit of written objective screening test, 23 candidates out of 405 were called for further evaluation

process on government notified parameters which was conducted on 28.12.2021. Final result was then declared on 05.03.2023 and 06 candidates were selected for the post of Auction Recorder including Nitin Azad who is the elder son of prime accused of Case FIR No. 04/22 Dated:23.12.2022 U/S 420,409,120-B,201 IPC & Section 7,7A,8,12,13(1)(a) PC Act(as amended in 2018) PS SV&ACB Hamirpur. During enquiry, it has been found that Smt. Uma Rani @ Uma Azad served as Senior Assistant, Erstwhile HPSSC, Hamiirpur. She had disclosed during her police custody in Case FIR No. 04/22 that she had given question paper of Post Code 899 i.e Auction Recorder to her elder son Nitin Azad before the exam scheduled on 11.09.2021 and as a result, Nitin Azad has acquired top position in the final merit list. The suspect candidates who were in contact with Nitin Azad have been interviewed and their Bank Details and CDRs have been analysed. Sh. Jitender Kumar, former Secretary, erstwhile HPSSC, Hamirpur served as Controller of Examination in addition to his duties as Secretary. As per para 14.08 of the Rules of Business & Procedure of the HPSSB Hamirpur, 2004, it is mentioned that "The question paper will be got printed by Secretary and secrecy, accuracy and quality of the printing will be ensured." Smt. Uma Rani @ Uma Azad wife of Sh. Naresh Kumar resident of House No. 306 Ward No. 7 Housing Board Colony, Hamirpur Distt. Hamirpur has served as Senior Assistant in Secrecy Branch at HPSSC, Hamirpur since 2019. Further the copies of manuscripts of Post Code 965 i.e. JOA (IT), Post Code 1003 (Computer Operator) & Post Code 1036 (Junior Auditor) have been recovered from her possession during search of her residential house during the investigation of case FIR No. 04/2022 dated 23.12.2022 u/s 420.120B IPC PS SV & ACB Hamirpur. The roles/involvement of any other official/Staff of HPSSC, Hamirpur, needs to be looked into during detailed investigation of this case. Necessary permission to register FIR against former Secretary, erstwhile HPSSC, Hamirpur u/s 17A of PC Act has been obtained from competent authority. Thus, as per the facts revealed on the basis of enquiry report and relevant record, a prima facie case for commission of offences punishable under section u/s 409, 420, 120B of IPC, Sec. 12, 13(1)(a) r/w 13(2) of Prevention of Corruption (amendment) Act, Sec. 5(1), 6, 10 of HP Prevention of Malpractices at University, Board or other Specified Examination Act, 1984 is made out against Smt. Uma Rani @ Uma Azad, her son Nitin Azad and the then Secretary of HPSSC Hamirpur, Mr. Jitender Kumar. Copy of FIR is being sent to the competent court and senior officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
