It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus on 03-01-2023 enguiry was ordered into the conduct of Post Code-970 (JE CIVIL) by HPSSC Hamirpur and the same was entrusted to Sub Inspector Sham Lal Enquiry Officer, Police Station SV&ACB Kullu, District Kullu. During the course of enquiry, the relevant record pertaining to Post Code 970 (JE CIVIL) has been procured from erstwhile HPSSC Hamirpur and the same has been scrutinized. On the perusal of record it is found that HPSSC, Hamirpur vide advertisement NO 38.2-2022 dated 24-05-2022 notified 12 posts of JE Civil, Post Code 970 on contract basis as per requisition made by Principal Chief Conservator of Forest (HOFF) HP Shimla-1. In response to this advertisement, 5524 candidates appeared in the screening test examination conducted at various examination centers in Himachal Pradesh on 10-09-2022 and 1653 candidates remained absent. Out of these 5524 appeared candidates total 36 candidates were shortlisted vide screening test result dated 05.11.2022. The final result has not yet been declared. Further, during enguiry the record received from HPSSC Hamirpur, bank statements received from various banks and interview of suspects revealed that Mukesh Bharti S/O Sh. Ranjeet Singh R/O VPO Tandi Tehsil Anni Distt. Kullu,

HP has submitted online application for the Post Code 970 JE (Civil) vide Application No. 4256233 dated 31.5.2022 under SC category. Mukesh Bharti appeared in this examination under Roll No. 970003275 at examination centre, Govt. boys Sr. Secondary School Kullu. The document verification of all 36 shortlisted candidates including Mukesh Bharti was scheduled on 25.11.2022 at the office of HPPSSC Hamirpur. Accordingly, Mukesh Bharti appeared for the document verification. From the tentative final list of result obtained from erstwhile HPSSC, it came to notice that Sh. Mukesh Kumar had obtained higest marks amongst 36 shortlisted candidates. The CDR analysis of suspects reveals that Ravi Kumar(tout) and Mukesh Bharti remained in contact with each other during schedule of examination and the Bank statements also show that an amount of Rs.100,000/ (One Lakh) was transferred on 01-09-2022 by Sh. Ranjeet Singh father of Mukesh Bharti from his Himachal Gramin bank Account No. 88280100031979 to SBI Account No. 20242916223 of Ravi Kumar (who is accused in Case FIR No. 03/23 PS SV&ACB Hamirpur) just 9 days before screening test i.e 10-09-2022 which substantiates that Mukesh Bharti illicitly procured question paper of this Post Code-970 JE (Civil) and secured 1st position (82 marks out of 100). In this way Mukesh Bharti, his father Ranjeet Singh and Ravi Kumar hatched criminal conspiracy and cheated general public and Government. Jitender Kumar, the then Secretary, Erstwhile HPSSC Hamirpur has not maintained the secrecy of question paper of this post code which subsequently resulted in leaking of question paper and consequently securing top position by one of the shortlisted candidate Mukesh Bharti with the connivance of Ravi Kumar and other public servants of HPSSC Hamirpur. There is a possibility of access of this guestion paper before examination date to other candidates als. These facts and roles of other candidates and employees of erstwhile, HPSSC Hamirpur need to be investigated. Necessary permission to register FIR against Jitender Kumar, the then Secretary, erstwhile HPSSC, Hamirpur u/s 17 A of PC ACT has been received from competent authority. Thus, as per the facts revealed on the basis of enquiry report and relevant record, a prima facie case for commission of offences punishable u/s 409,420,120-B IPC & section 12,13(1)(a) r/w sec 13(2) of P.C Act against Jitender Kumar, the then Secretary HPSSC, Mukesh Bharti, Ranjeet Singh, Ravi Kumar is made out. Copy of FIR is being sent to the competent Court and Senior Officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
