It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus on 03-01-2023 enquiry was ordered into the conduct of Post Code-971 (Lineman) by HPSSC Hamirpur and the same was entrusted to Insp. Chatter Singh Enquiry Officer, Police Station SV&ACB Shimla, District Shimla. During the course of enquiry, the relevant record pertaining to Post Code 971 (Lineman) has been procured from erstwhile HPSSC Hamirpur and the same has been scrutinized. On the perusal of record it is found that HPSSC, Hamirpur vide Advertisement No. 38/2-2022 dated 24-05-2022 notified 186 posts of Post Code-971 (Lineman). In response to this advertisement, 26087 on line registration applications (ORA) were received out of which 26619 applications were provisionally admitted and 19143 candidates appeared for screening test on 25-09-2022. Out of these 19143 candidates, total 738 candidates were shortlisted

vide screening test result dated 05.11.2022. The document verification of shortlisted candidates was conducted w.e.f. 25.11.2022 to 30.11.2022. The final result has not yet been declared. The CDRs, record obtained from erstwhile HPSSC Hamirpur and interrogation of Smt. Uma Rani @ Uma Azad (prime accused of Case FIR No. 04/22 PS SV&ACB Hamirpur) reveals that Sh. Manmohan S/O Sh. Hari Ram (Ex Employee (Daftari of erstwhile, HPSSC) R/O Village Chabot P.O. Amroh Tehsil & District Hamirpur H.P appeared in post code 971(Lineman) under Roll.No. 971005734 and got fourth position in the merit list of Gen./UR category with 77.50 Marks out of 100 as per tentative merit list. CDR analysis of suspects revealed that on 22.09.2022, Smt. Uma Rani contacted Sh. Hari Ram at 09:39 AM. At 09:43 AM, she then contacted Smt. Neetu Dogra and handed over the question paper to her which she provided to Sh. Hari Ram. Further from perusal of Rule of Business and Procedure of Himachal Pradesh Subordinate Services Selection Board, Hamirpur 2004, it is clear (under rule 14) that Sh. Jitender Kumar, the then Secretary, erstwhile HPSSC Hamirpur is responsible for maintaining panel of paper setters and evaluators to keep the secrecy, accuracy and quality. After receiving the question paper from paper setters, he used to prepare the manuscript without making any symbol/sign/code on it. He was responsible for sending the hand written paper/typed manuscript to printing press under a secret code. His act and conduct caused the leakage of secret documents related to Post Code 971 (Lineman). As per the preliminary facts and circumstances revealed during the course of enquiry a prima facie case under Sec. 409,420,120B IPC & 12 & 13(1) (a) read with 13(2) of PC Act 2018 is made out against (1) Sh. Jitender Kumar, the then Secretary HPSSC, Hamirpur (2) Smt. Uma Rani, the then Senior Assistant Secrecy Branch HPSSC, Hamirpur (3) Smt. Neetu Dogra W/O Sh. Rajneesh VPO Railli Jajri Teh. Badsar District Hamirpur (4) Sh. Hari Ram S/O Late Sh. Shakti Chand Vill.Chhagot PO Amroh Teh. & District Hamirpur (retired as Daftri from HPSSC) (5) Manmohan S/O Sh. Hari Ram Vill. Chhagot PO Amroh Teh. & District Hamirpur. Necessary permission u/s 17A PC Act 1988(as amended in 2018) has been obtained from competent authority following due procedure. The role/involvement of any other officials/persons needs to be investigated. Copy of FIR is being sent to the competent Court and Senior Officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
