It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspensions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus on 03-01-2023 enquiry was ordered into the conduct of examination of Post Code-977 (Market Supervisor) along with various post codes by HPSSC Hamirpur and the same was entrusted to SI Jasbeer Singh, Enquiry Officer, Police Station SV&ACB Una, District Una. During the course of enquiry, the relevant record pertaining to Post Code-977 (Market Supervisor) was procured from erstwhile HPSSC Hamirpur. Upon scrutiny of the record, it is found that HPSSC, Hamirpur vide advertisement No. 38- 2/2022 dated 24.05.2022 issued advertisement for recruitment of 12 posts of Marketing Supervisor on contract basis (post code - 977). In response to the advertisement, total 2427 applications were received and 1267 applications were admitted. The Written Objective Type Screening Test was held on 28.08.2022 in which total 726 candidates appeared out of which total 41 candidates were shortlisted for document verification. Document verification was conducted on 15.11.2022 at HPSSC Hamirpur. On completion of recruitment process, final result was declared on 15 December 2022 in which 12 candidates have been declared successful who are awaiting postings. It was further revealed that Uma Rani @ Uma Azad w/o Sh. Naresh Kumar r/o House No. E-306, Housing Board Colony, Ward No.-7 Tehsil & District Hamirpur, the then Senior Assistant posted in Examination(Secrecy) Branch of HPSSC Hamirpur and her son Nitin Azad(address as above) are

accused in case FIR No. 04/22 of PS SV & ACB Hamirpur. During her interrogation, Uma Rani @ Uma Azad had revealed that she had provided the question paper of Post code - 977 to her son Nitin Azad. Record analysis revealed that Nitin Azad had appeared in the said examination under Roll No. 977000315 and secured 1st position in SC category and 7th position in overall merit. It has been also revealed that as per Rule No. 14 of the Rules of business and procedure of the Himachal Pradesh Subordinate Services Selection Board, Hamirpur 2004, Sh. Jitender Kumar (HAS), the then Secretary HPSSC Hamirpur was responsible for maintaining panel of paper setters and evaluators, to keep the secrecy of question papers, printing of papers with secrecy, accuracy and quality. He was also the controller of examination. Enquiry revealed that he has not maintained the secrecy of question paper of this post code which resulted in leakage of question paper and Nitin Azad was benefitted with the connivance of Uma Rani @ Uma Azad. Necessary permission u/s 17 - A PC Act, 1988 (as amended 2018) and Para 4.2 of Chapter - II, Vigilance Manual to register a criminal case against Jitender Kumar (the then Secretary, HPSSC) has been obtained from competent authority after following due procedure. Hence, as per the preliminary facts and circumstances revealed during enquiry, a prima facie case u/s 409, 420, 120B IPC & 12 & 13(1) (a) read with 13(2) of PC Act 2018 is made out against (1) Sh. Jitender Kumar, the then Secretary HPSSC, Hamirpur and (2) Smt. Uma Rani, the then Senior Assistant Secrecy Branch HPSSC, Hamirpur (address as mentioned above) (3). Sh Nitin Azad (address as mentioned above). The role/involvement of any other officials/candidates/persons needs to be investigated. Copy of FIR is being sent to the competent Court and Senior Officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
