It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations held by HPSSC Hamirpur. Thus on 03-01-2023, enquiry was ordered into the conduct of Post Code-915 (Assistant Superintendent Jail/Welfare Officer-Cum-Assistant Superintendent Jail) by HPSSC Hamirpur alongwith various other post codes and the same was entrusted to Sub Insp. Jasbir Chand, Enquiry Officer, Police Station SV&ACB Una. During the course of enquiry, the relevant record pertaining to Post Code 915 (Assistant Superintendent Jail/Welfare Officer-Cum-Assistant Superintendent Jail) was procured from erstwhile HPSSC Hamirpur .Upon scrutiny of the record, it was found that HPSSC, Hamirpur advertised 05 posts of Assistant Superintendent Jail/Welfare Officer-Cum-Assistant Superintendent Jail Post Code – 915 vide Advertisement No. 37-01/2022 dated 19-08-2021.

In response to this advertisement, 10711 were received out of which 9050 applications were provisionally admitted. Written objective type screening test was conducted on 31.10.2021 and 5103 candidates appeared in the test. Further, 51 candidates were shortlisted and called for physical standard test which was conducted on 12.05.2022. Out of these 51 candidates, total 17 candidates were called for evaluation process as per govt. notified parameters on dated 29.07.2022. On the culmination of recruitment process, 05 candidates were declared successful by HPSSC Hamirpur vide notification dated 08.09.2022. Thereafter, 01 candidate from waiting list was selected on dated 14.10.2022. Hence, total 06 candidates were selected and appointed, who are undergoing training at Jail Training School, Punjab. It has been revealed that Uma Rani @ Uma Azad w/o Sh. Naresh Kumar r/o House No. E-306, Housing Board Colony, Ward No.-7 Tehsil & District Hamirpur, the then Senior Assistant posted in Examination(Secrecy) Branch of HPSSC Hamirpur is accused in case FIR No. 04/22 of PS SV & ACB Hamirpur. During enquiry it has been revealed that she had provided the question paper of Post Code-915 to Sh. Amit Kumar Sharma son of Sh. Madan Lal, retired Superintendent of HPSSC Hamirpur and Sh. Ravi Kumar s/o Sh. Hardev Singh r/o Village Ghanal Khurd Tehsil & Distt. Hamirpur. Amit Kumar himself was the candidate in the said test whereas Ravi Kumar was supposed to sell the question paper to other persons/candidates. She has revealed to provide the question paper to Ravi Kumar in lieu of Rs. 1.5 lacs which were exchanged at her house.

During the course of enquiry, CDRs of suspect/candidates, bank account statements etc. were procured and analyzed. It was found that candidate named Amit Kumar s/o Sh. Madan Lal R/o Ward No. 05, Talwar Tehsil Jaisinghpur Distt. Kangra who has secured 2nd position in the final selection list of the said test, was found in contact with Uma Rani @ Uma Azad telephonically during recruitment process of this post code. Sh. Amit Kumar had appeared in 52 exams conducted by HPSSC Hamirpur and HPPSC Shimla but got selected in Post Code 915 only after coming in contact with Uma Rani@Uma Azad.lt has been also transpired that Uma Rani@Uma Azad had brought the copy of manuscript of Post Code-915 with her on 17.09.2021 when it was sent for printing to the printer. Thereafter, Sh. Amit Kumar Sharma and Sh. Ravi Kumar were in frequent telephonic contact with her. Scrutiny of the bank details revealed that 02 lakh cash was withdrawn from the account of Sh. Madan Lal (father of Amit Kumar) on 21.09.2021. On the other hand, Ravi Kumar and Uma Rani @Uma Azad were also in frequent contact with each other telephonically. It was revealed that Ravi Kumar was working as taut of Uma Rani@Uma Azad. It has been revealed that as per Rule No. 14 of the Rules of business and procedure of the Himachal Pradesh Subordinate Services Selection Board, Hamirpur 2004, Sh. Jitender Kumar (HAS), the then Secretary HPSSC Hamirpur was completely responsible for maintaining secrecy of the process. Prima facie it appears that paper could be leaked due to criminal conspiracy between Jitender Kumar, Uma Azad, Ravi Kumar & Amit Kumar Sharma . As per preliminary facts revealed during course of enquiry a prima facie case under sections 406, 409, 420 & 120-B IPC and 7, 7-A, 8, 12 & 13(2) of PC Act is made out against (1) Sh. Jitender Kumar Kanwar (the then Secretary, HPSSC), (2) Smt. Uma Azad w/o Sh. Naresh Kumar r/o House No. 306, Ward No. 07, Housing Board Colony, Hamirpur (HP), Sr. Assistant at HPSSC Hamirpur, (3) Sh. Amit Kumar Sharma s/o Sh. Madan Lal r/o Ward No. 05, Talwar, Teh. Jaisinghpur, Distt. Kangra, selected candidate, and (4) Sh. Ravi Kumar s/o Sh. Hardev Singh r/o Vill Ghanal Khurd, Teh. & Distt. Hamirpur (HP) (Tout). Necessary permission against Jitender Kumar (the then Secretary HPSSC) has been obtained from concerned authority. The role/involvement of suspect candidates/officials of HPSSC Hamirpur can be verified into during the detailed investigation of this case. Copy of FIR is being sent to the competent
