It is submitted that consequent upon the registration of a criminal case FIR No. 04/2022 dated 23.12.2022 under section 420,120-B,201 IPC & section 7,7A,8,12 of Prevention of Corruption Act, 1988 (as amended in 2018) in respect of the question paper leak of Junior Office Assistant (Information Technology) Post Code-965 from Himachal Pradesh Staff Selection Commission Hamirpur, malpractices/suspicions have been reported by various source reports in the conduct of a number of examinations conducted by HPSSC Hamirpur. Thus on 03-01-2023 Enquiry No. SIT 06/2023 was ordered into the conduct of examination of Post Code-903 JOA(IT) along with various post codes by HPSSC Hamirpur and the same was entrusted to Inspector Mohinder Kumar, Investigating Officer, Police Station SV&ACB Dharamshala, District Kangra (HP). During the course of enquiry, the relevant record pertaining to Post Code-903 JOA (IT) was procured from the erstwhile HPSSC Hamirpur. Upon scrutiny of the record, it is found that HPSSC, Hamirpur vide advertisement No. 37-1/2021 dated 08.04.2021 and addendum dated 19.08.2021 issued advertisement for recruitment of 82 posts of JOA (IT) 903 on contract basis. In response to the advertisement, total 46581 applications were received and

41665 applications were provisionally admitted. The Written Objective Type Screening Test was held on 19.12.2021 in which total 20833 candidates appeared, out of which total 842 candidates were shortlisted for typing skill test. Typing skill test was conducted w.e.f. 5th to 7th May, 2022 at HPSSC Hamirpur in which 798 out of 842 appeared for the test and 695 candidates qualified the typing skill test. Further 272 candidates out of 695 were provisionally shortlisted for further selection process i.e. evaluation process, which was held w.e.f 12th to 14th Sept. 2022. The final result is yet to be declared. It was further revealed that Uma Rani @ Uma Azad w/o Sh. Naresh Kumar r/o House No. E-306, Housing Board Colony, Ward No.-7 Tehsil & District Hamirpur, the then Senior Assistant posted in Examination (Secrecy) Branch of HPSSC Hamirpur was deployed as Assistant Coordinator in Sub Division Hamirpur for the conduct of screening test for the post of JOA (IT) Post Code 903. The office order dated 15.12.2021 vide which the Assistant Coordinators were deployed to conduct this screening test, had imposed a condition that all the officers/officials concerned for strict compliance and ensure to submit "No relation certificate" before departure. Further as per information received from the erstwhile HPSSC Hamirpur, Smt. Uma Rani @ Uma Azad has not given any information with regard to appearing her close relative namely Shivani in the said examination. Smt. Uma Rani and her son Nitin Azad (address as above) are accused in case FIR No. 04/22 of PS SV&ACB Hamirpur. During interrogation, Uma Rani @ Uma Azad had revealed that she had provided the question paper of Post code-903 to her niece Ms. Shivani, who has secured first position in her respective category (SC-BPL).Another candidate namely Rama Devi who has secured 4th position in her category (Gen-UR) is also suspicious as she herself and her real brother Jai Chand driver of Jitender Kumar, the then Secretary, erstwhile HPSSC Hamirpur, is in close proximity with accused Uma Rani as per CDR analysis. It has been also revealed that as per Rule No. 14 of the Rules of business and procedure of the Himachal Pradesh Subordinate Services Selection Board, Hamirpur 2004, Sh. Jitender Kumar (HAS), the then Secretary, erstwhile HPSSC Hamirpur was responsible for maintaining panel of paper setters and evaluators, to keep the secrecy of question papers, printing of papers with secrecy, accuracy and quality. He was also the controller of examination. Enquiry report revealed that he has not maintained the secrecy of question paper of this post code, which has resulted in leakage of question paper. Necessary permission u/s 17-A PC Act, 1988 (as amended in 2018) to register a criminal case against Jitender Kumar (the then Secretary, erstwhile HPSSC Hamirpur) has been obtained from competent authority after following due procedure. Hence, as per the preliminary facts and circumstances revealed during enquiry, a prima facie case u/s 409,420,120B IPC & 12 & 13(1) (a) read with 13(2) of PC Act 2018 is made out against (1) Sh. Jitender Kumar, the then Secretary, erstwhile HPSSC, Hamirpur and (2) Smt. Uma Rani, the then Senior Assistant Secrecy Branch HPSSC, Hamirpur (address as mentioned above) (3) Jai Chand dvr HPSSC (4) Shivani daughter of Suresh Kumar Vill. Dabsai P.O. Bhira Distt. Hamirpur and (5) Rama Devi daughter of Shankar Lal Vill. Brayali P.O. Darlaghat, Solan (HP). Further the role/involvement of any other officials/candidates/persons needs to be investigated. Copy of FIR is being sent to the competent Court and Senior Officers for information and further necessary action. Relevant entries of FIR are being recorded in the concerned registers.
